Minutes November 20, 2020 Virtual Meeting via ZOOM

- I. Call to Order President James Rice.
- II. Roll Call A Quorum of Members being present (16 members). Meeting began at 1:33 pm.

New Members/Guest – None

III. Secretary's Report: Secretary Commerford stated that the minutes from the September 8, 2020 Zoom Meeting were sent to the members via listserve email and asked for a motion to accept the minutes. Scott Bartlett made a motion to approve the minutes as written, seconded by Marti Noel. President Rice called for a vote; 16-0-0 in favor.

(There were no minutes for October due to a lack of a quorum).

IV. Treasurer's Report: Treasurer Scott Bartlett sent out via listserve the Treasurer's Report and Income and Expense Statement dated September 8, 2020, October 20, 2020 and November 20, 2020. Mark Stetson made a motion to approve the report as presented, seconded by Marti Noel. President Rice called for a vote, 16-0-0 in favor.

Also, Treasurer Bartlett needs approval form the Board that will give the incoming President the authority to sign NHAAO check. Emily Goldstein made a motion to approve giving the incoming President the authority to sign NHAAO Checks. Seconded by Rosann Maurice-Lentz. President Rice called for a vote, 16-0-0 in favor. There is a form that the Secretary needs to sign that this was approved at a regularly scheduled Board meeting.

New Business:

Election Results - Election committee chair Mark Stetson read the results of the 2020 Election. See attached for the results. Mark thanked Sue Golden and Shelley Charon (from Avitar) for their efforts in assisting with the election.

Recertification Fee – In 2015, the Board voted to waive the re-certification fee for the 5 year cycle ending in 2020. The Board now needs to vote on whether to continue to waive the fee, reinstate the fee or do away with it altogether. After some discussion, Norm Bernaiche made a motion to re-instate the \$25 fee beginning in 2021 and have the Treasurer collect the fee when he sends out the membership dues. Seconded by Kris McAllister. President Rice called for a vote, 16-0-0 in favor.

Emily Goldstein brought up a concern regarding CNHA's whose status is listed as Retired or Honorary but are still performing assessment work in New Hampshire. Her concern was whether they should pay the regular membership fee. It was decided to bring this forward in 2021.

Education Committee – Verna stated that the committee would like to upgrade the version of the Cognito Forms they use to the Pro-level. This would make it easier to submit and process course applications. The cost is \$10 per month (for two users). Scott Bartlett made a motion to upgrade the Cognito Forms to the Pro version. Seconded by Kris McAllister. President Rice called for a vote, 16-0-0 in favor.

Election Committee – There was a concern brought to the election committee regarding requiring a signature on the back of the ballot envelope citing privacy issues. Our by-laws require a signature on the ballot. After some discussion it was decided to not change the current process but that if anyone has an issue with the current ballot process they could mail the ballot in their own third envelope.

Honorary Member – President Rice stated that Rick Brideau has retired and is recommending him for Honorary Membership. Jim Commerford made the motion to award Rick Brideau as an Honorary Member. Seconded by Marti Noel. President Rice called for a vote, 16-0-0 in favor. Congratulations Rick and thank you for your years of service to the NHAAO!

15 Year CNHA – Jim Commerford recognized Rick Vincent and Ed Tinker on achieving their 15 year CNHA status. Congratulations Rick and Ed!

Education Committee – Verna Sharpe announced that Steve Hamilton will be committee cochair in 2021.

Jim Michaud mentioned that Rick Brideau's retirement creates a vacancy for the Regional Director in Rockingham/Strafford County.

Adjournment: There being no further business before the Association Board of Directors, President Rice asked for a motion to adjourn the meeting; no objection, 16-0-0, unanimous in favor, the meeting adjourned at 2:07 pm.
